

- ▶ <u>10</u> new letter of intent was received
- ▶ 36 determinations of coverage for Certificate of Need review were made including waiver beds and acquisitions

The MHCC currently has 24 CON applications under review and 28 CON approved projects under development.

MHCC Certification helps assure that new or expanded facilities and services are consistent with the future health care needs of the people of Maryland. All projects certified by this Commission have been found consistent with the State Health Plan and review standard of this Commission.
