The Howard County Mental Health Authority (HCMHA) functions as the Core Service Agency (CSA) that is responsible for managing the publicly funded mental health system locally. HCMHA strongly supports the new proposed 100 bed facility here in Howard County. This new facility will bring added services to the local community that are greatly needed, such as a geriatrics unit, a specialized young adults unit, an eating disorders unit as well as two separate day hospital programs for adolescents and those with psychotic disorders. HCMHA is pleased to see the inclusion of a Crisis Walk-In Clinic as part of services that will be offered at this new facility. While individuals and families have been referred to the Charles Street campus in the past, the travel distance has been a problem for some.

Howard County's population now exceeds 300,000 individuals and data indicate that 93% of our population are covered by private health insurance. We are writing on behalf of the Howard County Delegation to the General Assembly in wholehearted support of a Certificate of Need application submitted by Sheppard Pratt for a psychiatric hospital facility in Elkridge, Maryland.

Currently, Sheppard Pratt Health System is the largest private provider of behavioral health and therapeutic special education services in Maryland. They currently have programs in 38 locations in 12 Maryland jurisdictions including two freestanding psychiatric hospitals, one in Towson and another in Ellicott City. These two hospitals alone have nearly 9,700 admissions annually. The will need to vacate their Ellicott City location in 2018, so they are doing preliminary planning for a new hospital in Elkridge. This new facility will be a 100 bed, 165,000 square foot facility costing approximately \$98 million, and will offer a broader array of inpatient, day hospital and crisis services that are now only offered on the Towson campus.
