## Applicant Response

The reference to an equity contribution of \$15 on page 46 of the application was an error. The correct amount of the equity contribution is \$17,653,372, as reflected in Table E. The reference to \$15 million in public and private sources is consistent with the amounts disclosed in Table E for philanthropy (\$7,500,000) and State grants or appropriations (\$7,500,000).
