

# Maryland Health Care Commission Dental Health Information Technology Initiative

#### **About The Initiative**

The Maryland Health Care Commission (MHCC) is engaging dentists and other stakeholders in discussions around the benefits and lessons learned from successful implementation of health information technology (health IT) in dental practices. The goal of the Dental Health IT Initiative is to promote adoption and optimal use of health IT among dental practices through peer to peer learning. Key components of health IT include:

- Electronic health records (EHRs), an electronic version of a patient's health record;
- Health information exchange (HIE), the secure electronic exchange of health information between providers; and
- Telehealth, the delivery of health services using telecommunications and related technologies.

EHR adoption is growing among Maryland dentists, with 60 percent reporting that they used an EHR in 2018 as compared to 53 percent in 2017.<sup>1</sup> Implementation of other health IT components is also expected to increase as federal efforts to promote health IT interoperability seek to connect providers across care settings. The benefits of using health IT include improved communication with providers and patients, reduced paperwork, and reductions in duplication and waste.<sup>2</sup>



#### **Key Activities**

#### **Health IT Assessment**

The MHCC collaborates with the Maryland State Dental Association (MSDA) and its component dental societies to conduct an annual health IT assessment of dentists licensed in Maryland. In 2019, the MHCC also began collaborating with the American Dental Association (ADA) to conduct a nationwide assessment of the utilization and perceived value of health IT. Information collected from these surveys is used to develop programs and educational resources for Maryland dentists.

#### **Shared Learning**

Shared learning is an opportunity for dentists and other dental professionals to learn about health IT from the experiences of their peers and from experts within the field. The MHCC facilitates these opportunities at various

events focused on interactive dialogue and sharing best practices among the dental community. Educational events take place at locations across the State and are offered in partnership with the MSDA and component societies for continuing education credits. Additional online learning events, such as Lunch & Learn webinars, offer convenient opportunities for dentists to receive information on topics of interest.

#### **Stakeholder Engagement**

By engaging stakeholders in efforts to identify challenges, areas of opportunities, and best practices associated with health IT adoption and utilization, MHCC develops sound policies and industry leading programs. The MHCC invites dental stakeholders to participate in staff advisory workgroups, such as the Dental Health IT Workgroup and the HIE Policy Board, to ensure that the industry is represented in policy and program decisions.
