# House Bill 581 (2013 Session)

- MHCC to select at least 5 palliative care pilot programs, in a manner to ensure geographic balance
- Report to General Assembly by Dec 1,2015
- Pilot programs to:
  - Collaborate with community providers
  - Gather data on costs, savings, access, and patient choice
  - Report to MHCC on best practices that can be used in the development of statewide standards

## **Request for Application Process**

- Convened leadership group with MHA and OHCQ
- Conducted 15 phone interviews with 19 hospital palliative care programs
- Developed Request for Applications (RFA): October 18 - November 8, 2013
- I4 applications submitted; 3 were assessed as not meeting minimum criteria

 What are the key legislative questions and what is our approach for addressing them? How many Maryland hospitals have a palliative care program?

- MHCC survey of Maryland hospitals
- Data from OHCQ and MHA
- DHMH Cancer Collaborative Survey of Maryland hospitals

What are the structural and operational characteristics of these programs?

- MHCC survey
- DHMH Cancer Collaborative data
- Annual filing (2012-2013) submitted to Center to Advance Palliative Care (CAPC) by pilot hospitals

What is the in-hospital experience of patients in Maryland palliative care programs?

- Data obtained by flagging palliative care patient discharges (July 1, 2014 - June 30, 2015) at pilot hospitals in the HSCRC discharge data base (DDB)
- DDB includes demographic, diagnostic, use and charge data
- Findings from pilot hospital studies
- Literature review

What is the out-of-hospital experience of palliative care patients?

- Difficult to follow patients post hospital with existing data sources
- No current direct data link from DDB to Medical Care Data Base
- Master Patient Identifier planned for implementation in 2015
- Findings from pilot hospital studies
- Literature review

What are the benefits of palliative care?

- Review and analyze use and charge data from DDB
- Compare to use and charge data of nonpalliative care patient discharges
- Report on satisfaction surveys developed by pilot hospitals

What standards should be recommended for palliative care programs?

- MHCC survey of key variables
- Assess standards and best practices in Maryland hospitals
- Address ability to meet national accreditation standards
- Literature review
