RE: Emergency Certificate of Need Application

LifeBridge Health, Inc. – Northwest Hospital Center, Inc.

Dear Mr. Steffen and Mr. McDonald:

Pursuant to COMAR 10.24.10.20, I write to seek an Emergency Certificate of Need ("CON") for projects at Northwest Hospital Center, Inc. ("Northwest Hospital"), located at 5401 Old Court Rd, Randallstown, MD 21133, that will expand LifeBridge Health, Inc.'s ("LifeBridge") capacity to accommodate the expected surge in hospital admissions and urgent need for additional hospital inpatient beds related to the COVID-19 pandemic.

To address the national state of emergency declared by the President and the United States Department of Health and Human Services, as well as the state of emergency and catastrophic health emergency declared by Governor Hogan on March 5th, LifeBridge Health is seeking approval to renovate and equip existing space at Northwest Hospital.

The various projects involve remodeling and/or equipping existing space to effectively manage patients requiring treatment for, or pending a diagnosis of COVID-19, as well as accommodate non-COVID-19 admissions (See Exhibit 1). The added capacity maximizes Northwest Hospital's ability to handle a potential surge of COVID-19 patients, while ensuring safe, specialized care for patients with other acute illnesses who require admission or observation.

Collectively, the projects will provide an additional 105 temporary beds and cost an estimated \$217,500. Two of the three Phase One projects have already been completed, with Phases Two, Three and Four able to be operationalized as needed, within three to seven days.

This Emergency CON, in combination with the additional 20 beds approved through the Emergency CON process by Ben Steffen on March 25th and subsequently approved by the MHCC on April 4th, aligns our temporary inpatient bed needs with our surge plan (all four phases). Our surge plan was developed in collaboration with the State of Maryland and Jenson Partners surge planners and submitted to the State of Maryland on April 6th. Our plan has also been shared with Baltimore County.

As outlined in Mr. Steffen's memo, dated March 17th, Northwest Hospital's surge plan will undoubtedly help address both the state's urgent need for an estimated "additional 500 inpatient beds" and provide a swift, timely response to the extraordinary "hazards to employees and patients" COVID19 poses.

As the unprecedented, catastrophic impact of this pandemic continues to rapidly effect the health and safety of our patients, staff, providers and every person throughout the state and country, we respectfully ask you act upon this request as soon as possible.
