The Maryland Health Care Commission has announced the following decisions on applications to build, enlarge, merge, or modify health services or facilities in the State. These decisions were made from March 1, 2019 through April 30, 2019.

Decisions of this nature apply to applications from proposed providers or sponsors seeking MHCC Certification of Need as required by State Law:

During this period the following decisions were made:

- ▶ <u>6</u> projects were approved with a cost of \$29,327,665
- ▶ <u>0</u> projects were denied
- ▶ <u>2</u> projects were voted upon for merger/consolidation, exemption, or declaratory ruling with a cost of \$43,675,541
- ▶ <u>1</u> project was deemed not needing Certificate of Need Review with passage of new legislation
- <u>0</u> previously approved projects were approved for a modification
- <u>0</u> approved projects were relinquished by the applicant
- <u>0</u> projects under review were withdrawn by the applicant
- <u>0</u> approved projects were revoked by the Commission

Also during this period the following occurred:

- <u>2</u> approved projects were pre-licensed for First Use or Partial First Use
- <u>0</u> new letters of intent was received
- <u>34</u> determinations of coverage for Certificate of Need review were made including waiver beds and acquisitions

The MHCC currently has <u>28</u> CON applications under review and <u>41</u> CON approved projects under development.

MHCC Certification helps assure that new or expanded facilities and services are consistent with the future health care needs of the people of Maryland. All projects certified by this Commission have been found consistent with the State Health Plan and review standard of this Commission.
