The Centers for Medicare & Medicaid Services (CMS) is pleased to provide the following preliminary report on your facility's data submission. As a reminder, program requirements are to submit appropriate quality data codes (QDCs) on at least 50 percent of your Medicare fee-for-service (FFS) claims and to submit web-based measure data for the following measures via QualityNet: ASC-6, ASC-7, ASC-9, and ASC-10.

This report contains a preview of your ASC's data submission status as of July 5, 2017, and contains a summary of your ASC claims, QDC submissions, and performance on both claims-based and web-based measures (as compared to ASCs nationwide). A full listing of the measures can be found in Appendix A.

The data in this report covers two payment determination years' worth of information (calendar year [CY] 2018 and CY 2019). Table A-1 provides an overview of the encounter period, deadline, and associated payment determination year for each of the measures displayed in this report.

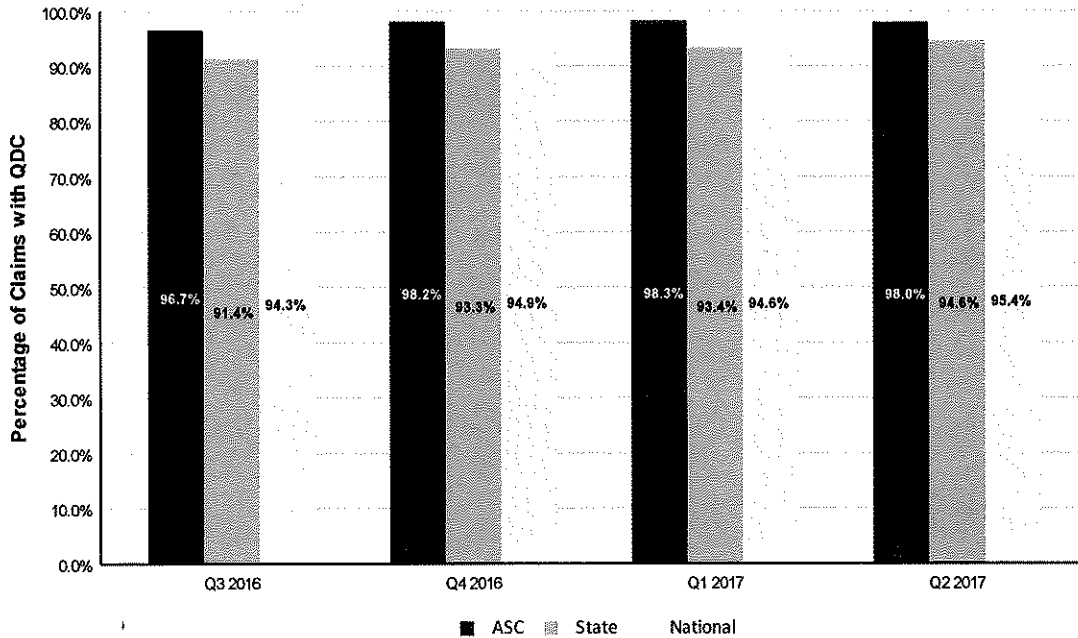

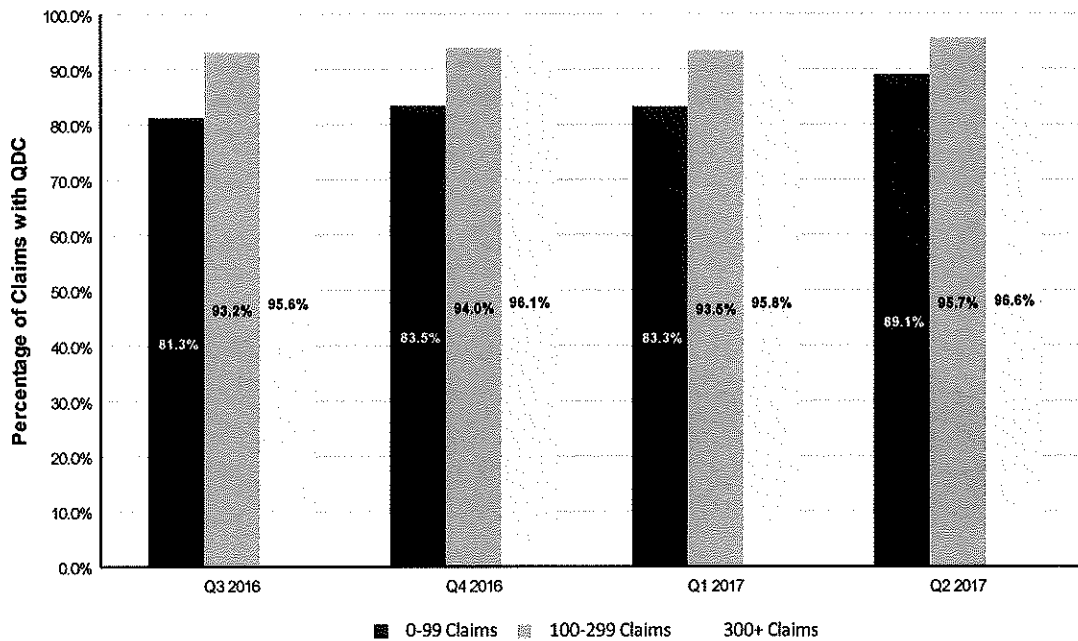

Figure 1—Percentage of Claims Containing QDCs



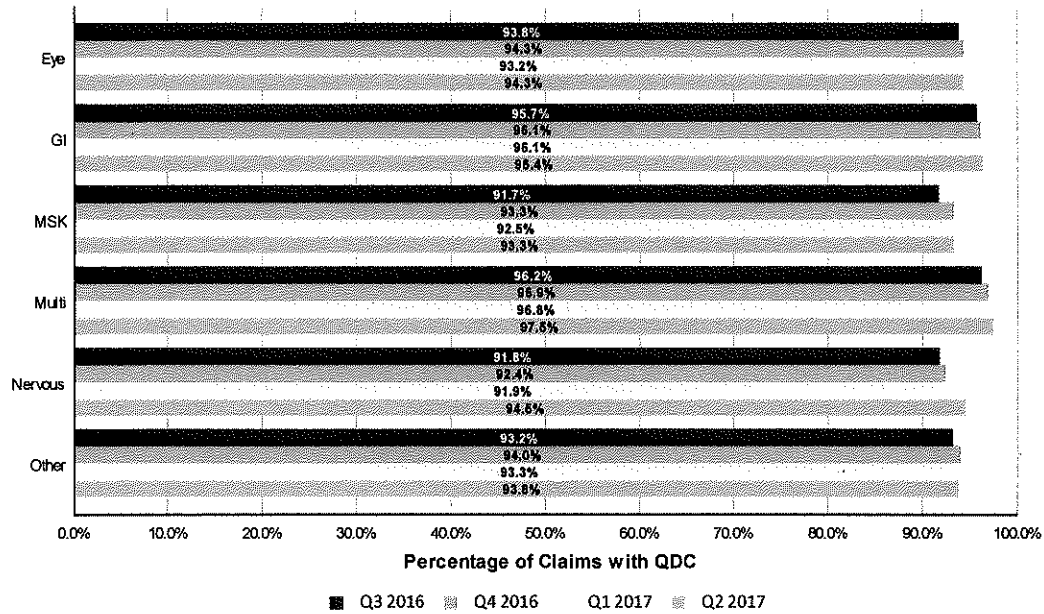

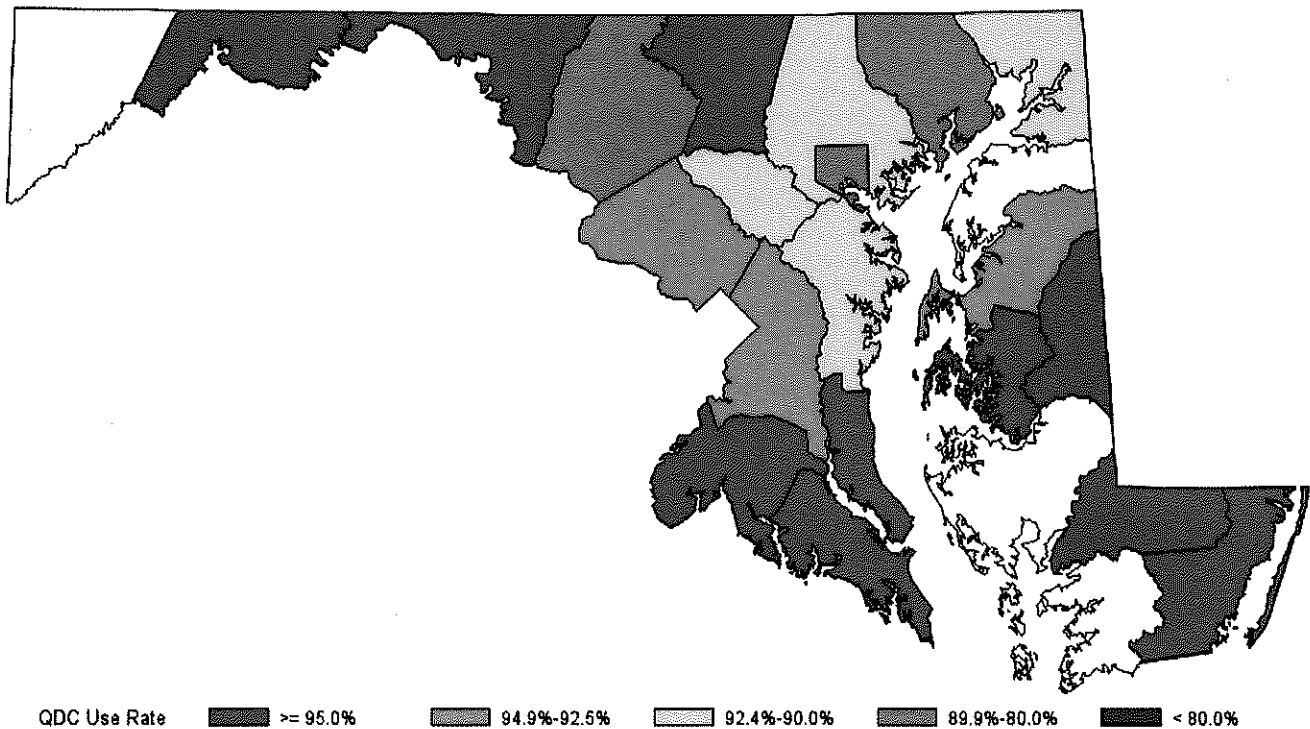
Figure 3—National Aggregates by ASC Specialty

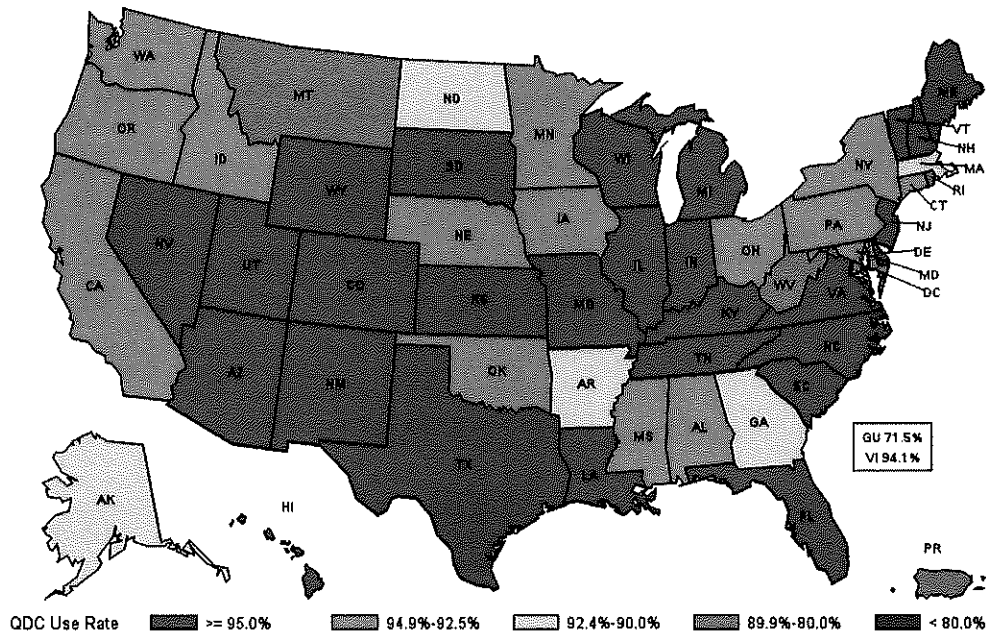
