

Note to Reader: Pursuant to Directives from the Secretary of the Maryland Department of Health, dated, respectively, June 12, 2020 and June 25, 2021, MHCC staff did not conduct annual licensed bed surveys for fiscal year (FY) 2021 and FY 2022. The total number of licensed beds granted to hospitals for FY 2020 remained the same for FY 2021 and FY 2022. For this reason, MHCC staff is unable to include details on the breakdown of licensed beds by hospital in FY 2021 and FY 2022 for tables that include trend information across those years.

MHCC staff did not conduct the annual supplemental surveys for FY 2022. For this reason, tables with inventory trends over time do not include data for 2021.








