

# **Using Telehealth in School Health Services**

Did you know use of telehealth by a school nurse can augment care delivery, decrease absenteeism, and improve academic performance for students? School nurses, in partnership with other health and education leaders, play a key role in developing protocols, standards, and guidelines for telehealth into school health services (e.g., student enrollment, consent, coordination of school nursing services with other health care providers, etc.). This webinar series will provide information on how telehealth can be leveraged in school health services and key policy considerations for program development across Maryland school districts. Presenters include local and national telehealth champions who will share success stories on strategies for implementation, specific telehealth use cases, and program benefits. ### Session 1: Workflows for Telehealth in School Health Services Starts with the Nurse

Presenter: Kelli Garber, MSN, APRN, PPCNP-BC, Lead Nurse Practitioner for School-Based Health and the Center for Telehealth at the Medical University of South Carolina What to expect: Learn about the process for modifying processes and clinical workflows to integrate telehealth into school health services workflows. Real-life examples will be shared from the lead nurse practitioner for a school-based telehealth program at the Center for Telehealth at the Medical University of South Carolina (MUSC). This includes how the program utilizes school nurses as telepresenters to virtually connect students to a nurse practitioner or pediatrician at MUSC.

## Session 2: Augmenting Delivery of School Health Services Using Telehealth
