

Noncontrolled Prescription Drugs Workgroup

Technical Discussion

January 23, 2023

SUMMARY

The Noncontrolled Prescription Drugs Workgroup (workgroup) convened on January 23, 2023 to complete a technical discussion of certain data fields based on versions of the ASAP (American Society for Automation in Pharmacy) 4.2B and NCPDP (National Council for Prescription Drug Programs) D.0. data transmission formats. Feedback provided by the workgroup will inform development of a Request for Proposals by the State Designated Health Information Exchange that seeks a vendor to collect and validate noncontrolled prescription drug information from dispensers for patients in Maryland.
