

Noncontrolled Prescription Drugs Workgroup

February 13, 2023

SUMMARY

The Noncontrolled Prescription Drugs Workgroup (workgroup) convened on February 13, 2023 to discuss potential privacy considerations pertaining to dispense information for noncontrolled prescription drugs (non-CDS) available through the State-Designated Health Information Exchange (CRISP). The workgroup discussed the need for making patients' medication history available to treating providers and risks of providers not having access to the data. Workgroup participants shared non-CDS privacy concerns and discussed the current process for consumers to opt out from having all clinical information shared by CRISP.
