SUMMARY

The Noncontrolled Prescription Drugs Workgroup (workgroup) convened on January 13th, 2023 to continue a technical discussion of data fields based on the ASAP (American Society for Automation in Pharmacy) 4.2B and NCPDP (National Council for Prescription Drug Programs) D.0 standards. Participants reviewed variables that could be reported to provide identifying information about a patient receiving a noncontrolled prescription drug dispense.
