#### Questions to Guide Recommendations



- ▶ Where are PC services provided? Where are the gaps in services?
- What are the geographic gaps in services? Other gaps: financial, demographic, diagnostic?
- ▶ What is needed for more widespread availability of PC services?
- ► Which organizations provide and/or promote PC services?
- ▶ What is the current state of financial coverage for PC: Medicare/ Medicaid/ private insurance?
- What models have worked in other states to expand coverage for PC services?
- ▶ What lessons were learned from the Maryland PC Survey in terms of future data collection?
- ► What does the public need to know about PC? What stakeholders are best equipped to provide information to the public?
- What is needed to provide professional education in order to increase referrals to PC?

#### Definition of Palliative Care



Palliative care is specialized medical care for people living with serious illness.

This type of care is focused on providing relief from the symptoms and stress of the illness.

The goal is to improve quality of life for both the patient and family.

Palliative care is provided by a specially-trained team of doctors, nurses,

and other specialists who work together with a patient's other doctors to provide an extra layer of support.

Palliative care is based on the needs of the patient, not on the patient's prognosis.

It is appropriate at any age and at any stage of a serious illness, and it can be provided along with curative treatment.
